National League Report - Joe

Fall session - 14 teams, 112 games played, 6 ties, 25 games with 1 run difference

Spring session - 16/12 player teams (192) 188 current plus new players today so teams will be full.

Rule 1+1+1 to waste will remain, per managers' vote.

Courtesy runner rule (3x per game) will remain, per managers' vote.

In order to accommodate the growing number of teams, there may be three (3) League days scheduled.

Julie reported that the official uniforms are not being worn, and the players are looking sloppy. The managers are responsible and they will be reminded at the next meeting.

Julie moved to encourage players to wear white long sleeves under their uniforms when it is cold, but the motion died with no second.

American League Report - Orie

Spring session - 13/11 player teams. Six (6) current players will not be drafted.

Managers agreed to new rules:

Tie breaker: the visiting team will receive an additional ½ run for the win.

Flip-flop rule: changed to seven (7) runs when visiting team is ahead.

Mercy rule: 15 after five (5) innings.

For a player who plays only one game a week, the same person cannot sub more than four (4) times.

OLD BUSINESS

Dues renewal: Checks only, no cash, easier to track. MUST use renewal form and provide copy of Rec. card, per Rec Center Board Policy -12A. Board members can no longer just verify and initial the form. Manned tables will be set up the next two weeks on Tues (Julie will coordinate) and Thurs (Jim) with forms and a copy machine to make it easier for renewals.

It was suggested we look into some sort of secure mailbox. (Vision Committee will address it)

Auxiliary Membership

Tabled at the last meeting. Orie moved/Chuck 2nd to create an auxiliary membership, (with no voting privileges) at \$5 per year. Carried.

Keys for Board Members

Jim asked how many wanted a key and several responded, so Arnie will work on rounding them up. Keys cannot be copied, nor the lock changed, per RCSC.

Rules & Regulations

The RCSC approved copy has not been received. Jim will check on it.

NEW BUSINESS

Petty Cash Increase

Steve Letko had suggested an increase from \$50 to \$100, but Julie indicated the audit shows no need.

P.A. System

Sidewinders have a system @ \$150, but Jim said he couldn't get it to work, so we won't buy it. Chuck moved/Orie 2nd to reimburse Julie for printer ink and keys made for the bulletin board. Carried.

Mandatory Officers Meeting

Jim will check on the RCSC meeting since we have not received information on it.

Web Site Operations:

Joe moved/Arnie 2nd to pay \$50 for the "Contribute" license for Orie's computer to allow him to maintain the Sun City website page. Carried.

MINUTES

December minutes were approved electronically, Chuck moved/Len 2nd to approve officially. Carried.

FINANCIAL REPORTS

Chuck reported the current figures showing all bills paid and a carryover balance.

The audit has been completed through Nov. 30.

Audit shows we received only 25% of the Sidewinders banner income instead of 50%. Chuck moved/Julie 2nd to bill the Sidewinders for the balance of \$419.50. Approved.

Jim directed Orie to bill SCW for 2/3 the cost of the 2011 Green Team new player's folders.

Short discussion on costs of different sized banners.

Subsequent meetings: Only agenda items will be discussed

JANUARY MINUTES - Julie

Sent electronically after the January meeting. Approved.

FINANCIAL REPORT - Orie

There were 98 renewals, 9 new players and 1 new sponsor payment. (Arizona Center for Cancer Care). Total membership at this time is 121.

Invoice for 16 dozen softballs has not been paid. There is a question about the quantity and the cost split. Since half the games are played at each field, each club receives half the balls, and payment is 1/3-2/3.

The cost to provide a new player with a uniform is \$53.00.

Orie moved/Chuck 2nd to set December 1st as the cut-off date to carry dues over to the following year.

Players joining before that date will pay the full dues and then renew in January. **Carried.**

Sidewinders - Discussion as to whether or not we are supposed to get 50% of the revenue. Julie read copies of Sun City Club minutes from Dec. 2005 and Nov. 2006 referencing the 50% split. She will research the audit records for payments received since that time.

A motion by Chuck to again request the 25% balance was tabled pending further information. It was questioned whether sponsors had made late payments after the April 2011 accounting. The total amount the Sidewinders received was \$1675 which represents 11 banners. Jim reported there are 20 banners displayed on the outfield fence. The next accounting will be as of April 1, 2012.

AMERICAN LEAGUE - Orie

Spring session - 13/11 player teams. Subs-6 and placement pool-6, but no 2-rated players available.

Coffee and donuts will be available on Thursdays. The board declined to purchase coffee pots and donuts, as none have been provided for the National League.

NATIONAL LEAGUE - Joe

There are 16 teams but short three players (2-rated) to fill 12-player rosters. Two byes each game day.

Incident Report: RCSC told Len that without two eye witnesses, no further action could be taken.

Due diligence is the only alternative.

VISION COMMMITTEE - Jim

Illegal bat signs will be posted by the dugouts.

Jim Wellman (RCSC Asst. GM) wants to meet with the club board about the field revamp.

GREEN TEAM - Len

Everything going well. A new player is rated AL-2 so will be placed immediately.

PLANNING, PUBLICITY & HOSPITALITY - Julie

The Club flyer was passed around which is being posted monthly at the Rec. Ctrs. by the Clubs & Activities office. Also the tri-fold brochure that is placed at the Visitor's Center.

Newcomer's Orientation - Weds, Feb 8, from 9-11 am and 7-9 pm at the Sundial Rec Center. Informational presentation by RCSC & the Visitor's Center for new homeowners from the past year, (and all residents) featuring highlights of the community. All the clubs are invited to reserve tables to talk with prospective members. Jim reserved a table; Julie & Joe will attend a.m. and Wayne will join her for the p.m. sessions.

SPONSORS - Len

Len visits sponsors once a month to say hello and delivers a newsletter.

He suggested having a short bio feature in the monthly newsletter for sponsors.

ADVERTISING - Jim

There are new banner forms and fee schedules available. He will assemble a team to solicit banner sponsorship. A company can supply their own banner, but must still sponsor the space.

UNIFORMS - Chuck

Currently need large shorts. Would like to keep an inventory of six of every item and try to ensure the shorts & pants have 3 pockets.

IT COMMITTEE - Joe

Joe moved/Wayne 2nd to keep all Sun City Club's membership records as well as all waivers (members and non-member player/guests) in the data base. **Carried**

OLD BUSINESS

Rules and Regulations (R&Rs) - have been approved by RCSC and the document has been received.

Non-member player/guest waivers - RCSC and the current R&Rs require signed waivers. Our current waiver applies only to new Sun City club members. Julie presented copies of a waiver for non-members & guests. **Julie moved/Chuck 2**nd **to adopt, carried.** She will also revise the Guest Team waiver.

FEBRUARY MINUTES - Julie

Submitted electronically after the February meeting. Orie moved/Len 2nd; approved.

FINANCIAL REPORT - Orie

There were 8 renewals and 4 new players.

Total membership at this time is 129: NL-80, AL-42, women-2, not assigned/non players/volunteers-5.

Invoice for softballs was paid and the SCW club reimbursed us for 2/3.

Green Team new player books - SCW Club reimbursed us 2/3 of the cost.

The SCW club has billed us \$13.75 postage for information concerning the co-mingling vote to be taken this week in SC West, which was mailed (without the SC Club's knowledge or consent) to SC club members who do not have email addresses. After considerable discussion, Orie moved/Joe 2nd to pay all current payables, including the postage. Carried.

Sidewinders - Julie gave an overview of a memo to the Sidewinders showing past receipts and the balance due under the 50% agreement. She did not have the copy but will email it to the board members.

AMERICAN LEAGUE - Orie

13 teams, seven players on the sub list, none on the placement list.

AL managers have received sign-up questionnaires for summer and fall session declarations.

NATIONAL LEAGUE - Joe

16 teams, one or two short due to injuries. Six on sub list. Five new players, four are AL rated.

Snow birds will begin leaving soon.

FIELD REPORT - Arnie

Thanks to the field crew that's doing a great job.

The pitching machine is working great for outfield practice, although can't be used for infield because of the backspin on the ball.

After meeting with Jim Wellman, Arnie said there was little information available regarding the field revamp. Julie suggested putting our questions and concerns in a letter; Jim said Mr. Wellman prefers emails. It is unknown what impact any field closure will have on the Summer or Fall sessions. Arnie will compile a list of concerns and questions and email Mr. Wellman.

GREEN TEAM - Len

Everything on track. Five new players today. Many are younger and the quality of players is good.

The books for new players are costing about \$5 each. Discussion: whether to bill SCW a flat 2/3 or per new SCW player. It was decided to track the number of players to determine which method to use.

PLANNING, PUBLICITY & HOSPITALITY - Julie

Newcomer's Orientation at the Sundial Rec Center last month was successful and several people were interested. Many are still employed and asked if there was a Saturday program, which is something we should consider. Thanks to Joe and Chuck for assisting Julie at the Club table.

SPONSORS - Len

Len plans to visit sponsors this week.

Sponsor renewal letters should go out soon and payments are due June 20.

Orie talked with a potential jersey and banner sponsor and gave Len the business card.

Jersey sponsor fees are \$500 for the first year (full amount goes to jersey costs) and \$250 thereafter (split is \$150 to jersey fund for future replacement of jerseys and \$100 to the club operating expenses.)

There is a waiting list for team sponsorship.

ADVERTISING - Jim

Jim handed out a new banner advertising form with costs for both sizes on one sheet.

UNIFORMS - Chuck

Nothing is needed right now, but plans to order in August or as needed.

Julie suggested that players be offered the choice of either shorts or pants, or both, and there was agreement.

Sox - Although the AL does not include sox as a part of the uniform, Len and other NL players feel that the striped knee sox are an important part of the team uniform. Chuck moved/Joe 2nd to buy sox. Carried.

IT COMMITTEE - Joe

No meetings have been held.

A proposal to bill the SC Club for incorrect email addresses was disallowed by the SC West president.

OLD BUSINESS

Sidewinders' Tournaments: (4) 2-day tournaments, beginning in the fall; four age levels of play. The club would receive a fee split of 50% (\$250) and provide food and beverages by donation. **Chuck moved/Len 2nd to accept offer, carried (one abstention)**

Due to the field size, bats will be limited and the ball core may need to be adjusted.

Julie presented the revised Team Waiver which uses the same language as the individual form. Blanks and signed waivers will be kept in a binder at the field.

Veteran's Tournament - Saturday Nov. 10 Jim will set up an online signup, Julie will make signup book(s) for the field(s). Cutoff date is October 31. Wayne will get managers and set up the teams. The Club will serve food and drinks by donation. (Len agreed to coordinate and set up PA system)

DISCUSSION

SPECIAL REQUEST BY MEMBER

Carl Johnson presented an overview of the Men's 70s League, including copies of the rules. The League is now governed by a Committee of Four (4): One (1) manager and one (1) spokes-person from each city. Plans to add another each city had to be dropped as there was an issue with field time in SCW and players did not wish to play all games in where field time is available. 2. A SCW player wants to override the current rules, have the 70s League under the control & supervision of the SCW Club and open the league to any 70 year old regardless of rated skills.

Carl asked the SC Board to consider these concerns and support the current League formation and rules.

Jim Keinath indicated that the Board could not resolve these problems since the 70s is outside the American and National Leagues.

Ronnie Guest suggested forming an AL 70s League to solve problem #2.

The minutes were then approved as corrected.

FINANCIAL REPORT - Orie

Report approved and submitted for the audit.

Julie moved/Chuck 2nd to transfer \$3000 from the Jerseys Fund to the Projects Fund and \$500 from

Jerseys to Current Expenses. Motion carried. There are still more than enough funds to cover three sets of jerseys that will be replaced in 2013.
