**American League** – Dennis Robins reported jerseys all accounted for and 6 teams for the 1<sup>st</sup> summer session with good balance among them

**Central/National** – Jim Smith indicated that each league has its own schedule with co-mingling with SC West

**Field Report**- Ron Coppess had a good meeting with Chris Herring re SC field projects, especially the batting cage to be installed along the left field line outside the fence. \$80 for golf and dinner (Fairway Rec Ctr), \$50 for golf only, \$30 for dinner only. Please have one check for the entire foursome and mail it to Tom Reynolds or place it in the mailbox at the ballpark.

**Questions** – The issue of co-mingling was raised, specifically in reference to the website – Dennis Robins stated that during COVID when we were separate, both SC and SCW had access to the website. Our webmasters are Tim Burke and Jack McCormack. Ron Coppess suggested that the co-mingling seems to be a minority position and that it will likely remain in the future.

**Green Team** – Rickie Toland passes out spread sheet with team tryouts – special recognition for assistants Pete Laufer, Jack McCormack, Jack Johnson, Mary Toland. The subject of identifying shirts for green teamers and grounds keepers was discussed – settled on "Field Manager", "Special Events Crew" and "Green Team staff".

American League – Dennis Robins indicated a successful, very competitive league of 11 teams with one bye. No major incidents and umpires doing well! Spring session looks like 12-13 teams, but more will be known after the three league committee meeting on Dec 27 9 AM at Beardsley Center. **American Report** – Dennis Robins reported there are 11 teams with 10 players each – new jerseys for a couple teams – umpires coordinated between SCW and SC.
